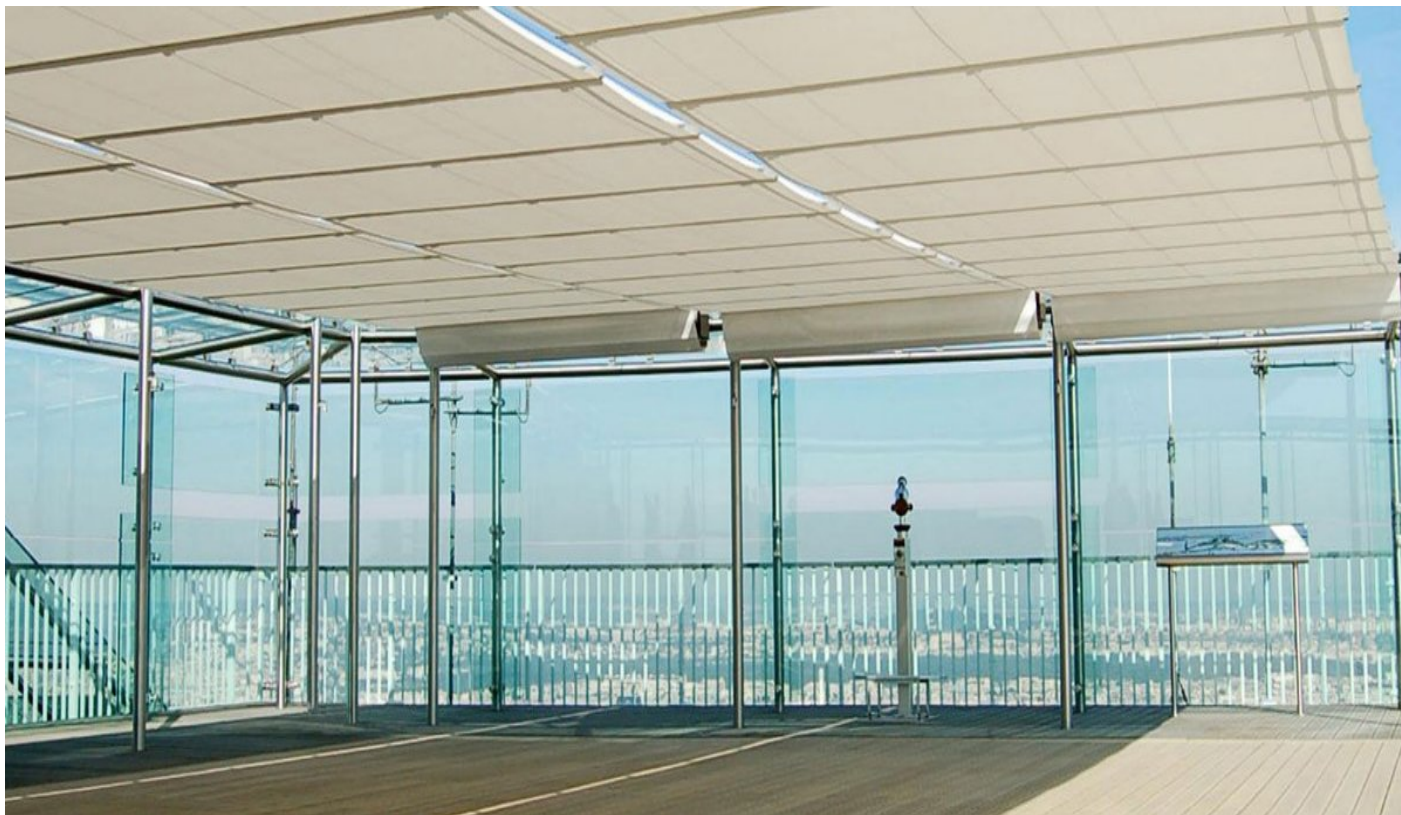

Designed for use in both outdoor and indoor with large plaza and terraces buildings

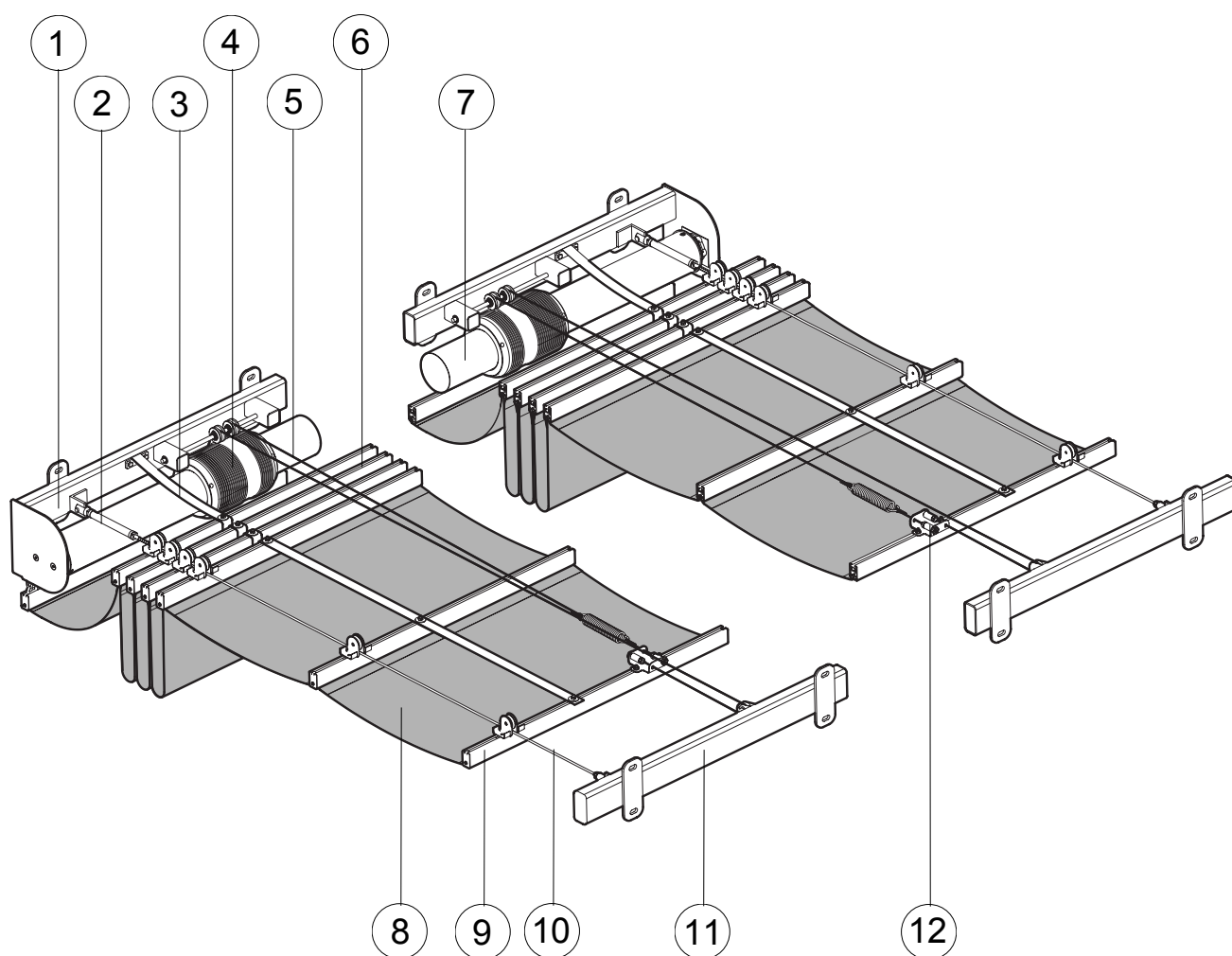

It is typically engineered for covering glazed roofs, plazas and terraces. This horizontal shading system is fixed to each end of the opening with no side fixings required. Available in a rectangular shape, the blind is divided into individual panels which are released and retracted using motorized cables. 6mm stainless steel wires are attached to support bars which use coated steel brackets.

Solange® 500 is a balanced combination of reliability and style, providing modern and advanced shade technologies to huge spaces. It is a perfect solution with versatile options as it offers flat or festooned fabrics with multiple colour options. We believe in first impressions and satisfying our clients is our priority. Introducing the 5 Year Warranty for ES Solange® Systems

As we trust the quality of our components and craftsmanship for our roller shading systems (Interior-Exterior use), therefore we give them a 5 year warranty. Euro Systems warrants the original purchasers that the hardware is of dependable service and is free of manufacturing defects in materials and workmanship for a period of 5 years.

The warranty period is defined to be the period of the project for which the product was originally purchased, from the date of shipping. This warranty does not depreciate in value. For full warranty details, please read the terms and conditions of our warranty.

Warranty Terms and Conditions

Warranty Terms and Conditions of Euro Systems. (Interior - Exterior large shadings) Euro Systems (ES) warrants to original purchasers that its products are free of manufacturing defects within factory products or workmanship for the following specified warranty periods:

Hardware

- 5 years of the interior project for which it was originally purchased, from the date of shipment for the Solange® motorized roller system

Motor (Interior use):

- 5 years from date of shipment for Solange® System products

Controls, Electrical, Electronic accessories:

- 2 years from date of shipment for Solange® System products

Fabrics :

- 5 years from date of shipment for Solange® System products

If any part of an ES product (except for images or artworks on fabrics) is found in the reasonable judgment of ES to be defective from factory materials or workmanship during the before prescribed warranty periods, ES will repair or replace the defective part at its own discretion. Repair or replacement under this warranty does not include labour or costs for installation, re-installation or removal of Euro Systems products, parts or components. The warranty valid to the original purchaser for all ES installed products.

The warranty does not apply if any of the following exclusions exist:

- The product has been subject to misuse, abuse, neglect, negligence, accident, or has been operated in any way contrary to the ES operating instructions or specifications.
